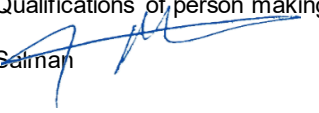
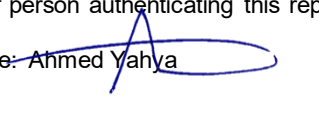

3. Remarks

The inspection included a detailed visual examination of the primary structural members, verification of the manufacturer's identification plate and CSC Safety Approval Plate, NDT examination of bottom lifting points, and assessment for corrosion, deformation, cracks, and any structural damage. No significant defects affecting the structural integrity of the container were identified during the inspection.

4. Conclusion

- Based on the satisfactory structural inspection, acceptable NDT results, engineering assessment, and considering the container age and unknown operational history, a conservative operational rated lifting capacity (derated capacity) of 20,000 kg has been assigned. This rating shall be considered the maximum allowable gross lifted weight for lifting operations under this certificate.
